Traditional Dues Option

- This option provides individual memberships for a **specific number of professional staff members**.
- The amount billed is based on the number of individuals included in the membership of the agency.
- If you have less than five (5) members, the amount for five (5) members is billed (or two (2) members for non-U.S. agencies). (For a sample dues schedule, refer to the table below.)
- Your agency will have the **flexibility** to add and replace members at any time - the amount billed will be adjusted to the number of members after the changes have been made.
